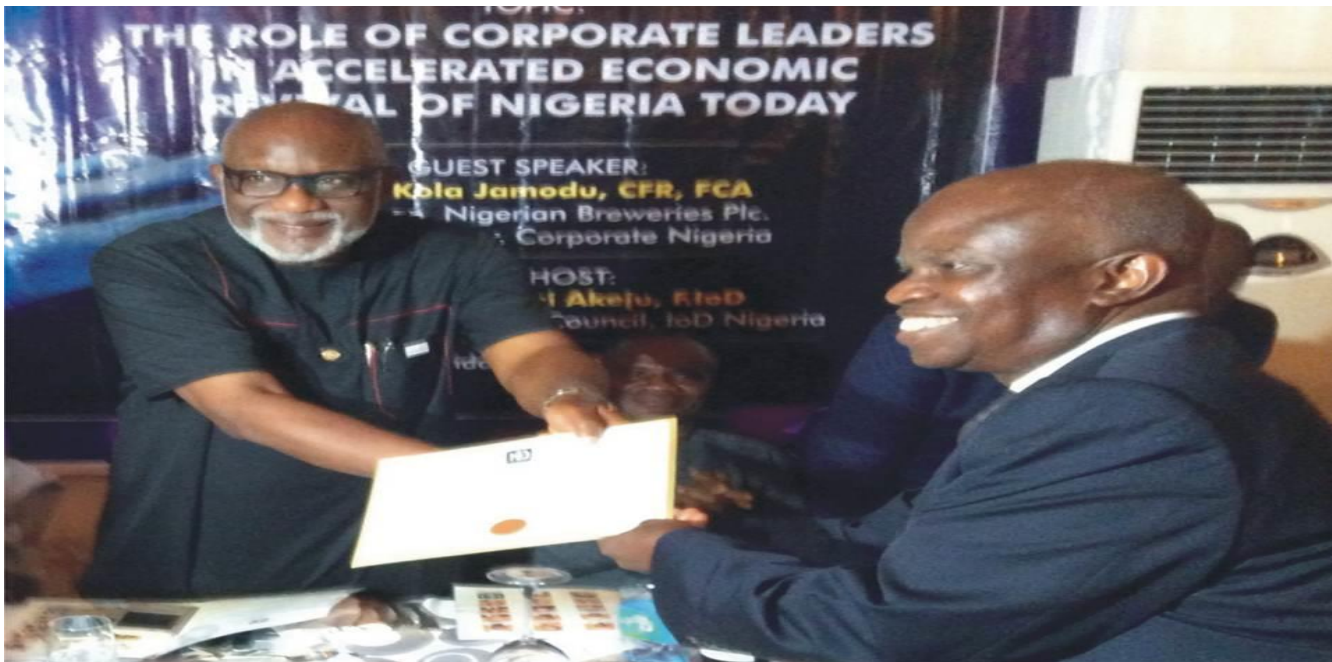

### Naira closes at 365 despite CBN dollar sales

The naira closed at 365 against the United States dollar at the parallel market segment of the foreign exchange market on Monday, down from 364/dollar it closed on Friday. This was despite the sales of \$462m and \$195m in the interbank forex market by the Central Bank of Nigeria on Friday and Monday, respectively. In line with its commitment to sustain and deepen flexibility in the forex market to further enhance forex flow in the economy, the CBN sold the total sum of \$462,336,426.74. A breakdown showed that the Retail Secondary Market Intervention Sales received the largest allocation of \$267.3m. The CBN also offered the sum of \$100m wholesale interventions, while the sum of \$50m was allocated to the Small and Medium Enterprises forex window. ### Nigeria loses N9.74b to public holidays in one year

Nigeria lost at least N9.74 billion in 2016 because of multiple public holidays observed during the year. The Guardian's investigation revealed that in 2016 alone, about 15 national public holidays were observed, excluding others declared in some states. Data from the National Bureau of Statistics (NBS) for the fourth quarter (Q4 2016) showed that 81,151,885 workers spent 37.38 million hours during the period to contribute N29.29 trillion to the economy at an average productivity rate of N783.51. Using the same estimates, with the expectation that workers spend an average of eight hours of productivity daily, 15 days of public holidays at N783.51 productivity value, means N9.74 billion, [Source: Guardian](#)

### FEC Approves New Petroleum Policy

In June, the nation's 2017 fiscal bill of N7.44 trillion (about \$24.5 billion) was enacted into law. But in it, \$7.5 billion (about N2.3 trillion is short of revenue target, popularly known as deficit. This shows about 31 per cent of the entire budget. For the Director-General, Budget Office of the Federation, Ben Akabueze, the plans by the Federal Government to fill up the gap by borrowing \$3.5 billion (about N1.1 trillion) in foreign loans and Eurobonds and \$4 billion (about N1.2 trillion) from the local debt market has been communicated. Tagged "Budget of Recovery and Growth," it is expected to address the ongoing recession last officially acknowledged last year and stimulate growth, through huge investments in power, roads, mass housing, security, among others. ### Complete your refinery before Dec 2019, FG urges Dangote

SCREENING of applicants for a \$150million joint World Bank and Federal Government fund has started in Abuja, it was learnt. It was learnt that the screening is aimed at strengthening the sector to ensure that only competent operators get the grant. It was gathered that many of the operators have been lobbying government 's officials to scale through the hurdles, which the government and the global banking body have put in place to wade off unqualified players. An official of the Ministry said it would not be business as usual for many applicants, as the government planned that only the best would benefit from the facility. According to him, a grant is different from a loan, adding that the Ministry of Solid Minerals wants to give the grant to people that would make good use of it. He said: "The government and the World Bank do not want the money to be misused by the beneficiaries. If you are an applicant and you are asking for the grant to buy equipment that would be used in the sector, you must justify the reason you are requesting for it. A lot of verifications must take place, before you are given the money. The officials of the government and the World Bank must ascertain the reason for the facility. That is why it is a facility, not a loan. Gone are the days when people get money and start marrying wives." [Source: The Nation](#)

## Police to arraign Dangote workers for N451m theft

The Police Special Fraud Unit on Monday stalled the arraignment of eight members of staff of the Dangote Sugar Refinery, Apapa, before a Lagos State High Court in Ikeja due to their inability to produce one of the defendants in court. The defendant, Mr. Habib Mande, and his company, El-Habib Property Nigeria Limited, were scheduled to be arraigned alongside eight workers of the sugar company for an alleged theft. The other defendants in the suit are Musa Sule, Joseph Ukpah, Babatunde Ajao, Onyekwere Chinedu, Alayande Rahaman, Omoro Ezekiel, Zainab Adebajo, Abugba Odion and Minnie Mohammed. The prosecuting counsel, Mr. Emmanuel Jackson, told the vacation judge, Justice Sedotein Ogunsanya, that he was ready to proceed with the arraignment of the other defendants. But the trial judge overruled him, insisting that all the defendants must all be present in court for their plea to be taken. [Source](#): Punch

The Federal Inland Revenue Services (FIRS) has reiterated its support for youth, entertainment and sports industry. The revenue generating agency cited the entertainment and youth sector as a major income earner.

The National Coordinator for awareness on tax reforms, Mr. Kunle Oseni, said this on Sunday at the 'Feet 'N' Tricks,' freestyle football championship prize presentation in Lagos, sponsored by the agency. Oseni said as much as FIRS job was to generate income for the government; it would also strive to support initiatives to encourage the country's vast youth population. He added: "Ordinarily, FIRS were created to generate revenue and account for the same revenue for the Federal Republic of Nigeria. What that means is that we are responsible for the three tiers of the government; the federal, state and the local government. "Recently, we found ourselves in a recession mode but we didn't go to sleep. We had to wake up, mitigate and enlighten the public so that they can know their social responsibility to their government. ### 'Mosquitoes resisting insecticidal nets'

Nigeria seems to be sitting on a keg of gun powder as efforts to control malaria are met with resistance. According to researchers, the progress Nigeria has made in combating malaria is coming under threat due to the spread of insecticide resistance (pyrethroid used in nets) by *Anopheles gambiae s.s.* and *Anopheles arabiensis*, the vectors that transmit malaria. The scientists that conducted the research for over 14 months said the reality and impact of resistance at the programme level was unfolding and it was believed that the loss of pyrethroid effectiveness would lead to increase in preventable deaths among most vulnerable groups. The malariologists that gathered at the Nigerian Institute of Medical research (NIMR) said their research has shown that there is evidence that insecticide resistance has been confirmed in at least 20 states across Nigeria. ### Nutrition: What do Nigerians eat?

Ms. Mary Arimond, Senior Technical Advisor, Centre for Dietary Intake Assessment at the Washington, DC office of FHI 360, looked at her audience comprising of nutrition experts from various federal ministries, agencies and the academia and asked what seemed a random question. "What did I eat yesterday, how much of each food and drink, how much milk was in my tea? How about the snacks, what was in that street food?" It was more than a random question, but one which is usually taken for granted by many Nigerians. According to Ms. Arimond, lack of information on diets means that information for food and nutrition policy is lacking. Nigeria's athletes and officials to the 2017 IAAF World Championships scheduled to begin on Friday in London are still stranded in Lagos as the delegation is yet to be issued travel visas by the United Kingdom High Commission. The contingent was originally scheduled to depart for the 16th Worlds this evening. Just last week, Nigeria's delegation to the Commonwealth Youth Games in Bahamas failed to make the trip as the team was denied both UK and USA transit visas. As at yesterday, 2017 America NCAA champion, Tobiloba Amusan who came into the country for the Worlds Trials in Abuja was yet to get her visa. Amusan, the second fastest Nigerian female sprint hurdler at 12.57 seconds, is the country's next biggest star after Blessing Okagbare-Ighoteguonor. Amusan is billed to make her Worlds debut at London 2017. Okagbare is not affected by the visa hassles as she has been in and out of UK this year for competitions. [Source](#): Thisday

### Neymar may fly to Paris today for PSG medical ahead of £196 million move

Brazil star Neymar will not head to Doha for a medical before completing a £196 million transfer from Barcelona to Paris Saint-Germain, but is instead likely to arrive in the French capital today, according to reports in France, writes [dailymail.co.uk](#). Le Parisien reported yesterday that 'everything suggests' Neymar will return to France from China, where he is visiting for promotional events, instead of heading to the middle east where PSG's owners, Qatar Sports Investments, are based. He could complete his world record transfer to the French side by the end of the week. The 25-year-old is expected to pen a six-year deal with the French club worth more than £500,000-a-week. Speaking with *The Nation* on phone, its National Vice President, Alhaji Abubakar Maigandi said sharp practices in the allocation and loading of the products was still a major threat to the free flow of fuel that this administration advocates. "There is corruption in those Nigerian National Petroleum Corporation (NNPC) depots; you have to give them money before you load in any of Warri, Port Harcourt and Kaduna refineries," he said.
