NOTICE TO ALL MEMBERS

The Institute has noted with dismay, that some members are delinquent in the payment of their **Annual Subscriptions**, which by statute are due in January each year.

The failure of any member to meet his or her financial obligations to the Institute is a violation of their oath of membership and a contravention of **Section 17 (4) of CIBN Act No. 5 of 2007**.

In view of the above, members in this category are advised to redeem all their outstanding membership subscriptions to the Institute.

To ameliorate the likely financial burden on the members affected, the Governing Council has magnanimously **granted a waiver of 50% to all members with outstanding subscription payable up till the year 2013**.

Members are by this announcement, enjoined to take advantage of this opportunity from the date of this publication till 31 December, 2014, to enable them to remain active and also benefit from all services offered by the Institute.

The Governing Council has however directed that members who have outstanding subscriptions for more than one year before December 31, 2014, will be deregistered in line with Section 8 (6) (d) of CIBN Act No. 5 of 2007.
